How?	All financial companies need to share customers' personal information to run their everyday business. How does Allworth and its Affiliates collect my personal information?	<ul> <li>We collect your personal information, for example, when you</li> <li>Open an account or apply for insurance;</li> <li>Seek advice about your investments;</li> <li>Provide contact information; or</li> <li>Make deposits or withdrawals from your account.</li> <li>We also collect your personal information from others, such as affiliates or other companies.</li> </ul>	
Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only</li> <li>Sharing for Affiliates' everyday business purposes—information about your creditworthiness</li> <li>Affiliates from using your information to market to you</li> <li>Sharing for nonaffiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing.</li> </ul>
