Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully in order to understand what we do.

How?	All financial companies need to share customers' personal information to run their everyday business. <p>How does Allworth and its Affiliates protect my personal information?</p>	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. Employees are trained on the proper handling of customer personal information.</p>
<p>How does Allworth and its Affiliates collect my personal information?</p>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> • Open an account or apply for insurance; • Seek advice about your investments; • Provide contact information; or • Make deposits or withdrawals from your account. <p>We also collect your personal information from others, such as affiliates or other companies.</p>
<p>Why can't I limit all sharing?</p>	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> • Sharing for Affiliates' everyday business purposes—information about your creditworthiness • Affiliates from using your information to market to you • Sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>

Use and disclosure of health information

To the extent you provide health information to Allworth for the purpose of applying for insurance products, such information will not be disclosed to nonaffiliated companies for any purpose, except:

- To underwrite or administer your insurance policy or related claims
- As required by law
- As authorized by you
